2021 TAX DEADLINE IS TUESDAY, OCTOBER 5.

Have you paid your car tax yet? Payments are due Oct. 5, 2021. Don't wait until the last minute - we have many ways to pay and extended hours to help make the process easy for everyone.

WAYS TO PAY

ONLINE

- Pay with an electronic check or credit/debit card at www.fairfaxcounty.gov/taxes/pay.
- **Electronic checks are FREE.**
- If using a credit/debit card, a third-party service fee applies.

PHONE

- Call 703-222-6740, TTY 711, to pay by telephone with your credit/debit card. A third-party service fee applies.

IN-PERSON

- Visit the Fairfax County Government Center, 12000 Government Center Parkway, Suite 223, Fairfax, VA 22035. For hours of operation, visit: www.fairfaxcounty.gov/taxes. Extended office hours will be available closer to the deadline - look online for details.
- Put a check or money order in the red drop boxes outside the Fairfax County Government Center.
- From Sept. 15 to Oct. 5, put your check or money order (*no cash*) in the following library book drops:

MAIL

- Make checks or money orders payable to "County of Fairfax." Use the envelope provided with your bill or mail to P.O. Box 10200, Fairfax, VA 22035-0200. (*No correspondence to this address, please.*)

Vehicles entering Fairfax County, whether newly purchased or moved in, must be registered with Fairfax County within 60 days of such event. Register your vehicle online www.fairfaxcounty.gov/taxes/vehicles/register-update-preface, by phone at 703-222-8234, TTY 711, or in person at the Government Center. **Registration with the Virginia Department of Motor Vehicles (DMV) must be done within the first 30 days and is separate from the local vehicle registration requirement with Fairfax County.**

If you have a question or concern about your bill, contact the Fairfax County Department of Tax Administration (DTA) at your earliest convenience - **avoid the last minute rush!**
